The Extra Class Question of the Day by Dan Romanchik, KB6NU

As many of you already know, I have written study guides for the Tech and General Class license exams (www.kb6nu.com/tech-manual). Until now, however, I've shied away from writing an Extra Class study guide. The two main reasons for this is that the material is much more complicated and there's a lot more of it.

This year, however, the NCVEC is updating the Extra Class question pool, and I've decided to bite the bullet and do it. So, I'm now in the process of writing a No-Nonsense Extra Class Study Guide.

After I got started on this, I had a D'oh! moment. It occurred to me that instead of just publishing this material in the study guide, I could also post some of it to my blog

(www.kb6nu.com). So, now I have the "Extra Class question of the Day" feature on KB6NU.Com.

In reality, it's usually more than just a single question because many of the questions are on the same topic. That's OK, though, because in reality, I don't post these every day. So, it all works out. Having said all that, here's an example. The correct answer to the question is in bold.

Extra Class question of the day: meteor scatter

Amateur radio operators use many different ways to get signals from one spot to another. Perhaps one of the most interesting is meteor scatter propagation.

Meteor scatter propagation is possible because when a meteor strikes the Earth's atmosphere, a cylindrical region of free electrons is formed at the **E layer** of the ionosphere. (E3A08) **28 - 148 MHz** is the frequency range that is well suited for meteor-scatter communications. (E3A09)

Unfortunately, these ionization trails are relatively short-lived, so to communicate via meteor scatter, you need

to either be able to detect when these paths are available or be transmitting when the paths are available. **All of these choices are correct** when talking about good techniques for making meteor-scatter contacts (E3A10):

- 15 second timed transmission sequences with stations alternating based on location
- Use of high speed CW or digital modes
- Short transmission with rapidly repeated call signs and signal reports

Mark's Mutterings

A New Old Tape Measure Beam

I've been wanting to build a tape-measure beam antenna for my HT for some time now, and when the January QST landed in my mailbox with an article describing a new design for one, I decided to stop procrastinating and start building!

The author, John Portune, W6NBC, managed to eliminate the PVC Tee and Cross fittings that are part of the traditional design, by drilling holes in the main PVC beam and passing the tape-measure antenna elements direct through the holes, reinforcing them with wooden dowels. It sounded like a clever way of simplifying the design. I bought all the material that I needed (less the coax and connector, which I already had in my junk box) for about six dollars at Home Depot.

I quickly discovered three problems with this design. First, drilling holes in PVC tubing is not easy. My first attempt was with a hand drill. The bit "bit" and before I could react, the PVC had cracked! Fortunately, I had a leftover piece of tubing that was long enough for a second attempt. This time I used a drill press and carefully worked my way up from a small pilot hole to the size I needed. The second problem is that the required 7/16" hole is not a standard bit size. Even Home Depot does not carry it, unless you buy a large and expensive set of bits. Fortunately we had one at work that I could borrow. The third problem is that it is not easy to drill three parallel holes in PVC pipe. I got around this by clamping the PVC between two pieces of scrap lumber so that it would "lay flat" under the drill press.

Once I had my holes drilled, the rest of the construction proceeded easily. I was only interested in 2 Meters, so I did not build the 70 cm part of the beam.

From where I live in Burlington I can only hit the .255 repeater with my HT if I stand by my second floor bedroom window and transmit on full (5W) power. With the new beam antenna, I can easily hit the repeater from anywhere inside the house using just 1 watt of power. I was never able to reach the

Walton repeater at all before; with the beam I now have no trouble at all, and I was able to monitor all the storm-related traffic during last week's tornado outbreak. This is one antenna project that turned out even more successfully than I had hoped!

Jen must have found my email address (and the email addresses of the club officers) from our club web site. Brian DeYoung, K4BRI, responded to Jen's request and drove to Elizabethtown. He had to sign non-disclosure agreements, so he can't say a lot about what happened. He did tell me that it "involved a form of Morse Code" and that the episode would air in late summer. He has promised to reveal more at the next club meeting.

Greg's QST Article

As Robert mentions in his Top of the Tower, Greg May (W2ORO) had an article published in the March QST. Greg provided a comparison of rotary encoders, and his article can be found under Technical Correspondence on pages 55 and 56. By my count, this makes *four* NKARC members who have been published in QST in recent years. Well done Greg!

NEW FCC Rules for the 60 Meter Ham Band

In summarizing the new rules, the FCC explained that they are intended to facilitate more efficient and effective use by the Amateur Radio Service of five channels in the 5330.5-5406.4 kHz band (the 60 meter band). The Commission stated, "Specifically, and consistent

with our proposals in the Notice of Proposed Rulemaking in this proceeding, the Commission replaces one of the channels with a less encumbered one, increases the maximum authorized power amateur stations may transmit in this band and authorizes amateur stations to transmit three additional emission designators. The Commission also adopts an additional operational rule that prohibits the use of automatically controlled digital stations

and makes editorial revisions to the relevant portions of the Table of Frequency Allocations and our service rules."

The Amateur Radio Service in the United States has a secondary allocation on 60 meters. Only amateurs who hold General, Advanced or Amateur Extra class licenses may operate on this band. Amateur stations must not cause harmful interference to — and must accept interference from — stations authorized by any administration in the fixed service, as well as mobile (except aeronautical mobile) stations authorized by the administrations of other countries.

The new rules expand the operating privileges previously available to amateurs. The band and the broadening of rules are the result of considerable hard work by ARRL. In obtaining the new rules as well as the

60M band, itself, League representatives to the US government needed to convince both the National Telecommunications Information Agency (NTIA) and the FCC to allow the band, and the expanded operating privileges. The NTIA, which manages the radiofrequency spectrum assigned to the Federal government, initially opposed assigning secondary use of 60M frequencies to amateurs.

The next step toward obtaining still greater privileges on 60M is to continue to demonstrate to the FCC and NTIA that hams are sufficiently skilled and disciplined to conform to the requirements of the new rules.

ARRL Recommends New Guidelines for 60M Use

Anticipating the expansion of amateur use of 60M, the ARRL Board of Directors directed the development of new operating guidelines for it.

The committee that was tasked to develop these was chaired by ARRL Second Vice President Bruce Frahm, K0BJ. ARISS Activity in Kentucky

There was a contact by the Academy @Shawnee of Louisville, KY with the International Space Station on February 14. The school is the Aerospace Magnet School for Jefferson County, Kentucky and has an attendance of about 500 students. The audio for this contact was relayed through Echolink (AMSAT Conference) and IRLP Node 9010.

World Radio Conference Establishes new Amateur Band

Amateurs have a new MF (Medium Frequency) allocation as a result of World Radio Conference 2012 (WRC 12). The band is 7 kHz wide and ranges from 472-479 kHz. US hams will have a secondary allocation.

Don't run out to buy surplus broadcast towers just yet, though. The allocation isn't effective until January 1, 2013. In addition, US amateur use cannot begin before the FCC has developed and adopted rules for the new band. US amateurs should be able to use a maximum 5-watt EIRP depending on their location and the rules developed by the FCC.

World Radio Conferences are functions of the International Telecommunications Union ITU) which is an arm of the United Nations. WRC 12 ended in Geneva, Switzerland on February 17.

New Clubs: My Nickel's Worth

It is always a thrill for me to receive an application

from a club to become affiliated with the ARRL. Healthy affiliated clubs are a great strength of the League — and of Amateur Radio. They often are the grease that allows ARRL to exert its muscle in fighting for the survival and greater strength of our great avocation, Too often this thrill is dashed when I learn that a new club was formed because of nasty in-fighting among members of an existing club. I don't mean over pure disagreements, but nasty actions that create deep, hard feelings. A problem with such situations is that fighting between club members generally does not stop with the forming of a new club. This fighting often moves from fighting among individuals to fighting between the old and the new club. This is not a healthy situation — not healthy for either club or for the individuals involved.

There is no doubt that whenever two or more people gather together in an effort, there can be — will be — disagreements. These disagreements can be healthy toward promoting energy and focus for the group, but they also can become pathologic if the parties involved allow them to become centered on individual personalities. The disagreement then often becomes one of personal pride involving individual-against-individual. What began as a discussion aimed at strengthening the club deteriorates into one to determine whose pride will win over another's pride.

The fracturing of one club into two becomes inevitable.

I am not talking about situations in which the parent club does not provide activities that meet the needs of groups of members. In such instances, it may logical to form a separate club with aims that differ from the parent club. Here, the two clubs and their memberships can continue to work together on common interests. The new club merely offers new outlets that the old club could not provide.

What I am getting at is that there is nothing more likely to result in nasty relations between people than when they allow disagreements to become personal instead of viewing them as tools that allow that promote grow. It has been my experience that no single individual has the best answer to a complicated issue. If we allow ourselves to believe we as individuals are the font of all

knowledge, we are wrong. When we personalize the debate by believing it centers on us as individuals, feelings are bound to be hurt and we begin to believe "it" is all about us when it should be about the club.

I strongly encourage everyone to realize we each are an important cog in the machinery of a club. We each have contributions to make to the success of the club. If we are to fulfill our goal of working to the benefit of the club and Amateur Radio, we must avoid reacting selfishly.

New clubs are great and needed. Founding a new club out of spite is neither great nor needed. Instead of forming a new club to get even with members of an existing club, would it not be best to swallow our pride, focus on the welfare of the group and get back to work to make the existing club better.

Back on the Air -- Reprise

Last month I commented on it being great to be back on the HF bands after having lost my tower in heavy winds a year ago. I'm still thrilled with the experiences I am enjoying once again. I also am still limited to 6, 10, 12, 15, 17 and 20 Meter bands, but a new wire antenna to cover down to 160 M is sitting next to my desk, awaiting my friendly, bow-and-arrow antenna raising friends and good "bow hunting" weather.

Part of the fun of operating is the ease of using Logbook of the World (LOTW). The number of DXpeditions and private stations that now use Logbook to QSL seems to be growing nearly exponentially. The cost of QSLing truly is dropping drastically. Moreover, the best is yet to come — it is scheduled for later this year.

I look forward, once again, to seeing you on the bands.


